On the 18th December 2006, the European Parliament and the Council of the European Union adopted a regulation on chemical substances (substances), titled Registration, Evaluation and Authorisation of Chemicals ("REACH"), EC No.1907/2006. Your assistance is necessary for xxxxxxxxx Limited to comply with this Regulation.

REACH provides a phase-in period during which substances can be pre-registered by the manufacturer or importer of the substance. The period for pre-registration is the 1st June 2008 through to the 30th November 2008. Substances that are not pre-registered during this period will be immediately subject to the full registration process and will lose the benefit of the phase-in period. To assure its compliance with the Regulation, xxxxxxx is requiring that all substances or preparations used in products sold to xxxxxx be pre-registered.

As a supplier of critical products and/or equipment and/or processes to xxxxx, you, or your supplier(s) if you are not the direct manufacturer of the substance/preparation, must pre-register all substances/preparations sold directly to xxxxxx or incorporated into purchases made by xxxxx. This Regulation mandates a comprehensive registration of all substances. Therefore, you must flow this requirement down your own supply chain.

Because safety and product integrity are of the utmost importance, it is essential that the manufacturers/suppliers of substances timely and properly pre-register them during the phase-in period to protect xxxxx's ability to continue shipping products to the EU. Your cooperation in this regard is, therefore, essential.

Attached to this letter is a Questionnaire regarding your intent to pre-register substances in products sold to Moog. You are required to complete and return this Questionnaire by the 29th February 2008. If you or any of your suppliers do not intend to pre-register a particular substance, you must advise xxxxx as early as possible.

In the coming months, you will be receiving additional correspondence and questions from xxxxx seeking information needed to comply with REACH. We look forward to partnering with you as we navigate through this complex process.
