Dear Valued Customer,

We are pleased to share this announcement of a change in the relationship between Nestlé HealthCare Nutrition, Inc. ("Nestlé") and Moog Medical Devices Group ("Moog"), the manufacturer of EnteraLite[®] Infinity[®] Pumps and Administration Sets. Following a successful three-year partnership in which Nestlé has been the exclusive distributor in the United States and Canada of the EnteraLite[®] Infinity[®] Pumps and Sets, our two companies have mutually come to a strategic agreement that Moog will resume responsibility for the sale and distribution of EnteraLite[®] Infinity[®] products in the United States and Canada.

Please note that this agreement between Nestlé and Moog encompasses ONLY EnteraLite[®] Infinity[®] Pumps and Sets. It does <u>not</u> include COMPAT[®] branded feeding tube products, Nestlé enteral nutrition formula or Nestlé oral nutritional supplements, all of which will continue to be sold by Nestlé. A complete list of the EnteraLite[®] Infinity[®] products that are included with this agreement is set forth in the table on page 2.

We recognize that this agreement will affect how you purchase EnteraLite[®] Infinity[®] products and we are committed to working closely with you to make this transition as seamless as possible. To facilitate a smooth transition, Nestlé and Moog have agreed to the following:

- Nestlé will continue with "business as usual" during a transition period that begins today and will extend for three months, through June 30, 2016 (the "Transition Period"). This means that you can continue to place orders for EnteraLite[®] Infinity[®] Pumps and Sets directly from Nestlé, in the same manner as you currently operate, throughout the Transition Period.
- Effective July 1, 2016 you will purchase your EnteraLite[®] Infinity[®] Pumps and Sets from Moog or from a distributor that has
 established a purchasing relationship with Moog for EnteraLite[®] Infinity[®] Pumps and Sets. During the Transition Period,
 Moog will work directly with you to set up an account with them if one does not already exist, to assure a smooth transition
 to Moog. Please also note that Nestlé and Moog may work to transition customers to Moog throughout the Transition
 Period; therefore, you may be asked to begin ordering from Moog at an earlier date.
- Because Nestlé's contract with you contains both EnteraLite[®] Infinity[®] Pumps and Sets, as well as other products that will continue to be sold by Nestlé, your existing contract with Nestlé will continue in full force and effect, except that the EnteraLite[®] Infinity[®] Pumps and Sets listed on page 2 of this letter will be removed from that contract by Nestlé effective July 1, 2016. As of that date, the EnteraLite[®] Infinity[®] products will transition to Moog. Please be advised that this letter serves as formal notice of the removal of these products from your contract with Nestlé effective July 1, 2016. Nestlé and Moog will work with you to assure a smooth transition of any contractual agreement.
- If you are currently renting EnteraLite[®] Infinity[®] Pumps from Nestlé, you will need to enter into a new rental agreement with Moog or, if you choose not to do so, you will need to either purchase or return the rental pumps pursuant to the process described in your rental agreement.
- Effective July 1, 2016, all orders for EnteraLite[®] Infinity[®] Pumps and Sets will need to be placed with Moog or with a
 distributor that has established a purchasing relationship with Moog for EnteraLite[®] Infinity[®] Pumps and Sets. If ordering
 from Moog, please contact Moog at 1-800-970-2337 or by email at medcustomerservice@moog.com.
- There will be no change to your ordering process for all other Nestlé products.
