Explanation of Responses:

- Shares held by a living trust of which the reporting person's spouse is the trustee.
- On February 16, 2022, 9,410 shares of Class A common stock were transferred by the reporting person to a living trust of which the reporting person is the trustee.
- This represents the difference between the number of SARs exercised (7,000) and the number of shares issued as a result of the exercise (2,353). The number of shares to be issued under a SAR exercise is determined by multiplying the number of SARs being exercised by the difference between the FMV on the date of exercise (\$80.23) and the exercise price (\$36.41). Additional shares are then withheld to satisfy the Company's tax withholding obligations.
- Shares held by a living trust of which the reporting person is the trustee.
- Shares held by an irrevocable trust of which the reporting person's spouse is the trustee.
- Shares held by a grantor retained annuity trust of which the reporting person is the trustee.
- Reflects shares held in Moog Inc. Retirement Savings Plan as of the most recent report to participants.
- Stock Appreciation Rights (SAR) granted under the 2008 Incentive Stock Option Plan.
- SARs become exercisable ratably over three years beginning on the first anniversary from the date of grant.
- Stock Appreciation Rights (SAR) granted under the Moog Inc. 2014 Long Term Incentive Plan.
