- Includes 224 shares of Class B Common acquired under the Moog Inc. Employee Stock Purchase Plan on December 31, 2017 and July 1, 2018.
- Reflects shares held in Moog Inc. Retirement Savings Plan as of the most recent statement to participants.
- Stock Appreciation Right (SAR) granted under the 2008 Appreciation Rights Plan.
- SARs become exercisable ratably over three years beginning on the first anniversary from the date of grant.
- Stock Appreciation Rights (SAR) granted under the Moog Inc. 2014 Long Term Incentive Plan.
