**Explanation of Responses:**

1. These shares of Class A Common stock are held by a revocable trust, of which the reporting person's spouse is the sole beneficiary and the sole trustee.

3. The performance-based restricted stock units were granted under an equity incentive compensation plan maintained by Moog Inc. and therefore the reporting person paid no price for the performance-based restricted stock units.
4. Shares withheld for taxes upon the settlement in shares of performance-based restricted stock units previously granted to the reporting person.
5. Stock bonus granted under the Moog Inc. 2014 Long Term Incentive Plan.
6. Reflects shares held in Moog Inc. Retirement Savings Plan as of the most recent report to participants.
7. Stock Appreciation Rights (SAR) granted under the 2008 Incentive Stock Option Plan.
8. SARs become exercisable ratably over three years beginning on the first anniversary from the date of grant.
9. Stock Appreciation Rights (SAR) granted under the Moog Inc. 2014 Long Term Incentive Plan.
