**Certification Regarding Responsibility Matters (FAR 52.209-5):**

- (1) The Offeror certifies, to the best of its knowledge and belief, that:
- (i) The Offeror and/or any of its Principals -

- (b) The Offeror shall provide immediate written notice to the Buyer if, at any time prior to contract award, the Offeror learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
- (c) A certification that any of the items in paragraph (a) of this provision exists will not necessarily result in withholding of an award under this solicitation. However, the certification will be considered in connection with a determination of the Offeror's responsibility.
