  - ➤ Base / Travel rate: Monday thru Friday, 8 am to 5 pm local time including travel labor.
  - Assumes a daily 8-hour workday plus a 1-hour meal break (no charge to Customer).
  - > O/T rate applicable to any hours other than those between 8 AM to 5 PM Monday thru Friday and Saturdays, local time.
  - > Holiday rate is applicable to Sundays and Holidays.
- Extended Duration Rate Labor Categories
  - Available for use on the 8<sup>th</sup> consecutive workday and beyond (as applicable).
  - Assumes a daily 10-hour workday (exclusive of any meal breaks).
  - Any hours worked over the average daily 10-hour workday shall be billed using the Extended Duration Daily Hourly Rate.
  - ➤ O/T shall apply, using the Extended Duration Hourly Rate, for hours worked over the average 10-hour workday.
- FSR Travel time All labor for travel, from the FSR's home or office to the local lodging and any labor for travel from local lodging to the work location will be charged at the Base/Travel rate or Extended Daily Hourly rate as applicable.

- > Travel expenses are all total cost expenses incurred from start of trip from employee's home or office to his return to end location. Includes local mileage and airport parking of personnel vehicle, or cab fare, whichever is applicable.
- ➤ Hotel accommodations made at mid-priced hotels acceptable for business travel such as Hampton Inn, Holiday Inn, etc. or better if not available.
- At a minimum, car rental, since the Field Service Representatives generally travel with a set of hand tools, etc., is midsize cars unless the location / destination environment requires a vehicle to travel unimproved roads, weathered or off-road terrain, in which a SUV shall be used.
- Any need for material / parts / assemblies to be supplied by Moog's FSR shall be billed at Moog's General Service Administration (GSA) / Commercial Price.
- ➤ High Risk Assignments are determined by Moog's internal *Duty of Care* process. *Duty of Care* is characterized by any of the following: Prime Customer confirmation, Information as provided by Moog's Third-Party Risk Management Partner, Public Information and / or Government sponsored programs. The Extended Rate assumes use of its respective Base Rate for a High-Risk Assignment Deployment.
